BUSINESS-TO-BUSINESS DEBT RECOVERY SERVICE

Are you a UK business and owed money in respect of an unpaid invoice or account by another UK business? WBW Solicitors offers a free business-to-business debt recovery service, commission-free and no hidden charges (subject to terms and conditions). All you need to pay is the disbursements (such as court fees).

Providing the debt is uncontested, is between £250 and £5000, incurred after 7th August 2002, and is owed to your business by another active UK business, you will not be charged for our debt recovery service and our fees will be claimed from the debtor (full terms and conditions available upon request).
